- The key words that are used in the file noting of the official documents are translated from English/Hindi into Sanskrit and are circulated for their official use in the Campuses. So Sanskrit is mentioned in file notes accordingly.
- The sign board displayed at the main entrance has included with the writing of the name of the Campus, name of the University and the address in Sanskrit.
- There is a board behind the Director which also displays the details written in Sanskrit.
- There are banners/posters, everywhere visible in the campuses, which are neatly written slokas in Sanskrit with their translations in English and Hindi.

The University with its envisaged vision about the preservation and propagation of Sanskrit learning embarks on that mission relentlessly pursuing its

goal in an incredible manner. The history is the proof for its transformation from Rashtriya Sanskrit Sansthan, established under Societies Act in 1970 to the status of a Deemed to be University in 2002 and finally culminating into a Central Sanskrit University in 2020. The journey is simply incredible.

- Its logo, "Yonnuchanahsa no mahan", taken from Shalyaparva of the Mahabharata explains its motto driving the point that one cannot be great due to riches, silvery hair in old age, influence etc, but through the knowledge one gains from the Sages and Rishis.
- This signifies the Institution's thrust on the main point, 'knowledge' to make its students the Cultural sentinels in safeguarding our cultural heritage for the future generations.

It has forty Ordinances which are prepared in accordance with the Section 29(2) of the Central Sanskrit Act, 2020 read with Statutes 39 and 40 thereof, available in its official website.

- It has also "Regulations of Recruitment Rules and Service Conditions of the Non-Teaching employees and "Regulations of MuktaSwadhyayaPeetham".
- It has entered into MoU with IGNOU etc., and the details are available on its website.
- All of its official notifications on various, Academic, Examination and others are uploaded on the website as and when they are notified.
- The information on entrance tests, admissions, fee details, dates of examinations, time-table, examination fee details etc., are available on its wall and the students can download their admit cards and IDs and certificates from the website.
- It has well defined policies on transfer, staff car and endowment chairs available on the website.
